WHEREAS, the Tarlac State University advertised the Invitation to Bid for the project Supply and Delivery of Shoes for SCUAA 2025 (APP 2024), Rebid, with an Approved Budget for the Contract (ABC) of ₱ 1,819,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 8, 2025;

**WHEREAS,** in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at TSU- BAC Conference Room and webcasted via Zoom on January 16, 2025;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on January 28, 2025, at 2:00 P.M., Three (3) bidders, namely, Gabson Trading, Topcoms Marketing Corp., and Sonak Corp., participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Gabson Trading, and Topcoms Marketing Corp., contained all the required documents and were rated "passed", while the first envelope of Sonak Corp., was found to be ineligible due to an expired PhilGEPS Registration, which is not current and updated;

**WHEREAS**, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the two bidders and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bids of the two bidders with the results as summarized below:

APPROVED BUDGET FOR THE CONTRACT (ABC): P 1,819,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Shoes for SCUAA 2025 (APP 2024), Rebid, with an Approved Budget for the Contract (ABC) of ₱ 1,819,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 8, 2025;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on January 16, 2025;

WHEREAS, in the public bidding held at the BAC Conference Room on January 28, 2025, at 2:00 P.M.:

- (a) Three bidders, namely, Gabson Trading, Topcoms Marketing Corp., and Sonak Corp., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Gabson Trading, and Topcoms Marketing Corp., contained all the required documents and were rated "passed", while the first envelope of Sonak Corp., was found to be ineligible due to an expired PhilGEPS Registration, which is not current and updated.
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the two bidders and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the two bidders whose first and second envelopes were rated "passed",
- (e) the BAC resolved to declare Gabson Trading, the bidder with the Lowest Calculated Bid (LCB) with bid amount of ₱ 1,250,500.00,
- (f) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on February 6, 2025;

- (a) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.
- (b) the TWG for Technical Aspect reported that the LCB was non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive;
- (d) the BAC directed the Secretariat to issue the Notice of Disqualification to Gabson Trading.
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of Topcoms Marketing Corp., the 2<sup>nd</sup> Lowest Calculated Bid.

On January 31, 2025. Sonak Corp., sent a Motion for Reconsideration.

On February 5, 2025, the BAC through the Secretariat responded via email that due to its defects during the opening of bids, its Motion for Reconsideration was denied.

WHEREAS, in the Post-Qualification Evaluation Conference at the BAC Conference Room and via zoom on February 7, 2025:

- (a) the TWG for the Legal and Financial Aspects reported that the 2<sup>nd</sup> LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.
- (b) the TWG for Technical Aspect reported that the 2<sup>nd</sup> LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 2<sup>nd</sup> LCB as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as if is hereby RESOLVED:

- (a) to declare Topcoms Marketing Corp., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 1,483,000,00 and.
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of Shoes for SCUAA 2025 (APP 2024). Rebid. to Topcoms Marketing Corp.
